

Cattlemen 100 MTB 2020 Edition TERMS & CONDITIONS

- The Cattlemen 100 MTB is organised by Alps Link Regional Communities Development Association Inc. ABN: 22 178 866 133
- 2. The participant accepts that they are entering the Cattlemen 100 MTB at their own risk and by registering, agrees, that they are both mentally and physically capable of riding the distance they have chosen.
- 3. The participant accepts the event they have chosen as either competitive or non-competitive.
- 4. Participants agree their personal information may be collected may and used by The Cattlemen team for communication, safety and medical reasons. This includes the use of emergency contact information if a medical transport is required. All rider information will be stored in line with the Victorian data protection laws.
- 5. The event registration form must be completed by a person aged 18 years or over. Evidence of age may be requested. If a rider is under the age of 18 parental consent must be provided.
- 6. The participant is fully responsible for their actions whilst at the event. It is expected that the participant act in a safe and responsible manner pre/post and within the ride itself.
- 7. It is mandatory for cyclists to wear appropriate attire, including a helmet that regulates with government standards. The Cattlemen 100 team reserves the right to disqualify participants who do not to wear a helmet during the ride.
- 8. The participant confirms that the bike they are riding in the Cattlemen 100 is suitable for the terrain of the event and is road worthy. The bicycle the participant chooses to ride will have the ability to withstand, paved, non-paved and backcountry terrain.
- 9. During the event there will be directional and safety signage. The participant accepts that they will be cycling on public roads and all road rules apply. Participants are expected to be competent bike riders and be able to adjust to the conditions.
- The Cattlemen 100 spans across 160kms of terrain participants understand that using vehicle assistance at any time during the ride results in automatic disqualification.

CATTLEMEN 100 MTB -OMEO-

- 11. As a condition of entry it will be mandatory for riders to carry their mobile phone at all times. Their personal information (name and phone number) will be available to key event personnel during post and pre event.
- 12. The Cattlemen 100 reserves the right to change the route at anytime.
- 13. No motorized or power assisted bicycles, including but not limited to E-bikes, are not permitted when riding the Cattlemen 100 MTB.
- 14. To the best of their ability participants will follow the course route mapped out for them and will not take any short cuts.
- 15. Participants agree that any photography taken throughout the course can be used as promotional material. The participant herby releases the Cattlemen 100 from any and all liability from such use of promotion. The participant waives any right to any compensation they may have for appearing in any promotional material.
- 16. Each participant will be fully responsible for any fees or costs incurred or arising from an accident either involving or caused by the rider. This includes, but not exclusive to, fees from Police, Ambulance, Fire and Rescue. If the situation arises that you are not capable of making the decision to call the emergency service, the rider agrees that a member of the Cattlemen 100 events team or a member of the public may call for them. In this situation, the rider still accepts the costs and consequences of such actions. It is recommended that the participant has an Ambulance Victoria membership.
- 17. Upon registering, participants will provide correct medical and insurance information, if they have available. Although not compulsory, the Cattlemen 100 suggests that all participants acquire rider insurance such as a week license through Cycling Victoria. The participant understands that if they choose not to they are fully liable for any damages, injury or other caused to themselves or others.
- 18. The Cattlemen 100 is not responsible for any damages caused to bikes and or accessories throughout the race, or pre/post race. The Cattlemen 100 does not take responsibility for any items that have been stolen, misplaced or mistreated. It is up to participants to take care of their own property.
- 19. Participants agree to receive pre and post event communication from the Cattlemen 100 event staff.
- 20. Upon registering, participants will, to the best of their ability, agree to attend all briefings set out by them prior to the event.
- 21. Upon approaching a checkpoint all participants will abide by Covid safe practices.
- 22. The Rider acknowledges and agrees that participation in The Cattlemen 100 is dangerous and that they participate in the event at their own risk.
- 23. It is understood that the date of the event will be held on Saturday 28th of November, unless otherwise revised due to Covid19 or other restrictions.

COVID19 Refund Policy Summary Cattlemen MTB 100 2020

Along with many industries, it has been a tough years for events, we are excited to go ahead with the Cattlemen 100 MTB, which will be held on Saturday 28th November 2020.

We understand there is some apprehension in purchasing tickets for this event due to the current circumstances. In light of this we have implemented cancellation and refund policies for your peace of mind.

What if the Victorian Government prevents from the event going ahead?

If the Victorian or Federal Government restrictions are still heavily in place and the Cattlemen 100 MTB needs to reschedule or cancel the event, riders have the option to cancel their entry and receive a credit to a rescheduled event (within 18 months) or receive a full refund.

What if the event proceeds but Government restrictions prevent me from travelling?

If you are in a postcode or area of lockdown that restricts you from travelling than the Cattlemen 100 MTB will allow participants to cancel their entry and receive credit to a rescheduled event (within 18 months) or receive a full refund.

What if I cannot attend the event due to medical or reasons other than Covid19?

If cancellation of participation occurs within 48hours from the event time than a full refund or credit will NOT be issued. However, any cancellation made with more than 48 hours notice will be issued a full refund or credit.
